A motion to pay the bills was made by Achterhoff and supported by West. **Motion Carries.**

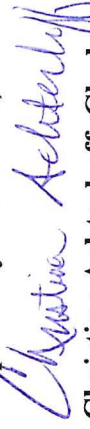
